

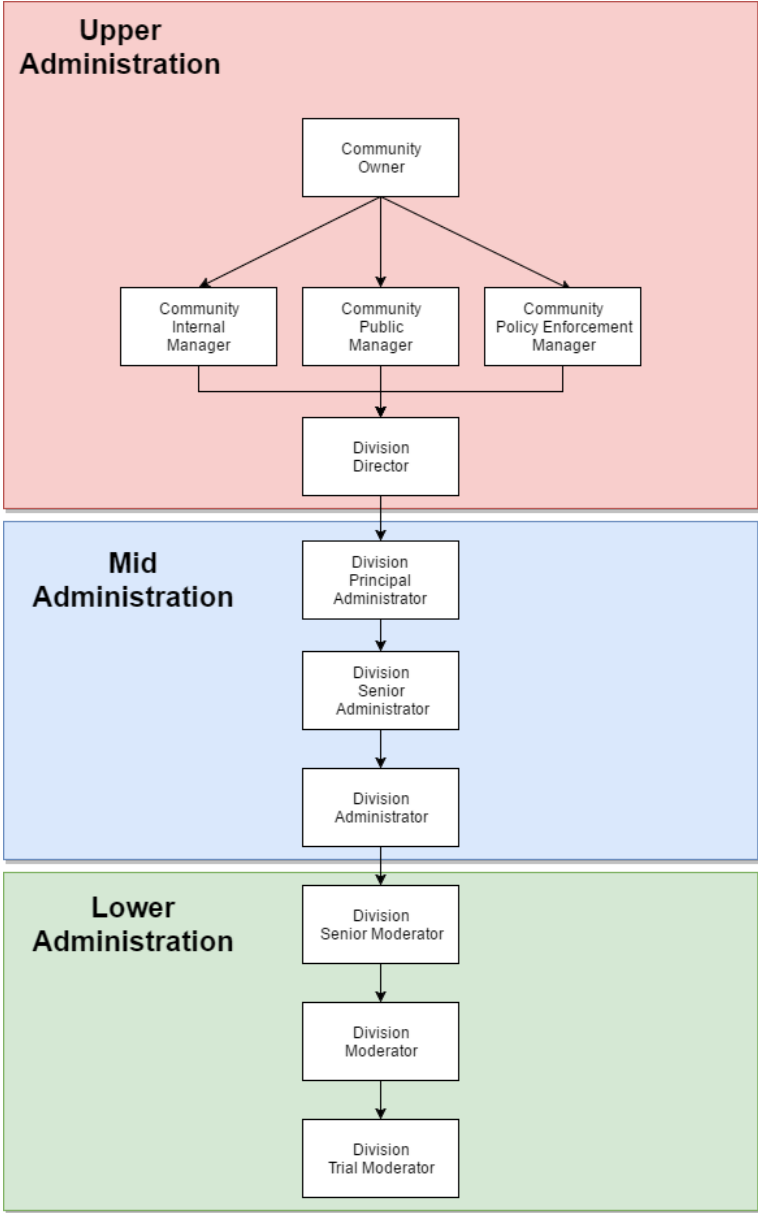


Community Structure

Upper Administration

Community Owner

Duties: Oversee the community

Privileges: All

Requirements: Own the community

Reports to: The Community

Community Internal Manager

Duties: Manage the daily affairs of the administration, including corruption/abuse cases.

Privileges: All

Requirements: Appointed by the Community Owner

Reports to: Community President

Community Public Manager

Duties: Manage the daily affairs of the community, addressing concerns and conflicts not related to the administration, handling support and congress threads.

Privileges: All

Requirements: Appointed by the Community Owner

Reports to: Community President

Community Policy Enforcement Manager

Duties: Manage the general rule policy of the community, such as adding/modifying/removing rules and their respective sentencing and having ultimate/final say on the interpretation of a rule.

Privileges: All

Requirements: Appointed by the Community Owner

Reports to: Community President

Mid Administration

Division Principal Administrator

Duties: Ensure that server rules are being followed, applying the proper actions when necessary to enforce them. Mentor new moderators on how to properly behave and the proper procedures to enforce the rules.

Privileges: Administrator Server Moderation, petition for a new Trial Moderator

Requirements: 6 months service as Senior Administrator, with no violations

Reports to: Division Director

Violation Policy:

Severe Violation: Case-by-case basis

Major Violation: Case-by-case basis

Minor Violation: 1x warning, followed by demotion to Division Administrator

Division Senior Administrator

Duties: Ensure that server rules are being followed, applying the proper actions when necessary to enforce them. Mentor new moderators on how to properly behave and the proper procedures to enforce the rules.

Privileges: Administrator Server Moderation, petition for a new Trial Moderator

Requirements: 3 months service as Administrator, with no violations

Reports to: Division Director

Violation Policy:

Major Violation: 1x warning, followed by demotion to Senior Moderator

Minor Violation: 1x warning, followed by demotion to Division Administrator

Division Administrator

Division Senior Moderator

Duties: Ensure that server rules are being followed, applying the proper actions when necessary to enforce them.

Requirements: 3 months service as Moderator, with no major violations

Reports to: Division Director

Violation Policy:

Severe Violation: Termination

Major Violation: 1x warning, followed by demotion to Moderator

Minor Violation: 1x warning, followed by demotion to Moderator

Division Moderator

Duties: Ensure that server rules are being followed, applying the proper actions when necessary to enforce them.

Privileges: Server Moderation

Requirements: 1 month of service as Trial Moderator, with no severe or major violations

Reports to: Assigned Division Administrator

Violation Policy:

Severe Violation: Termination

Major Violation: Demotion to Trial Moderator

Minor Violation: 1x warning, followed by demotion to Trial Moderator

Division Trial Moderator

Duties: Ensure that server rules are being followed, applying the proper actions when necessary to enforce them.

Privileges: Server Moderation

Requirements: Appointed by Division Director or with the support of 3x Division

Mid-Administrators

Reports to: Assigned Division Administrator

Violation Policy:

Severe Violation: Termination

Major Violation: Termination

Minor Violation: 1x warning, followed by termination
